### 1. Umum

PT. Eatertainment International Tbk. didirikan pertama kali dengan nama "PT. The Green Pub" berdasarkan akta No. 46 tanggal 14 Maret 1980, juncto akta "Perubahan" No. 65 tanggal 29 April 1980, dari Soelaiman Ardjasasmita SH, Notaris di Jakarta. Anggaran Dasar tersebut telah disetujui oleh Menteri Kehakiman Republik Indonesia tanggal 26 Juli 1980 No. Y.A.5/264/20 dan telah didaftarkan pada Kantor Pengadilan Negeri Jakarta dengan No. 4404 dan No. 4405 pada tanggal 27 Agustus 1980 serta telah diumumkan dalam Berita Negara Republik Indonesia tanggal 30 November 1984 No. 96 tambahan No. 116. Berdasarkan Akta No. 42 tanggal 10 Mei 1996 dari Lieke L. Tukgali SH, Notaris di Jakarta merubah nama perseroan terbatas "PT. The Green Pub" menjadi perseroan terbatas PT. Setiamandiri Mitratama.

Berdasarkan Akta No. 66 tanggal 25 Juni 2004 dari Fathiah Helmi SH, Notaris di Jakarta merubah nama perseroan terbatas PT. Setiamandiri Mitratama Tbk. menjadi perseroan terbatas PT. Eatertainment International Tbk.

Perseroan berkedudukan di Jakarta dan berdasarkan pasal 3 anggaran dasar Perusahaan, ruang lingkup Perusahaan adalah menjalankan usaha-usaha dalam bidang restaurant, pertunjukan-pertunjukan, jasa, perdagangan, pengangkutan dan keagenan.

### 1. General

*PT. Eatertainment International, Tbk. (the Company) was established with first name "PT. The Green Pub", based on notarial deed of Soelaiman Ardjasasmita, SH No. 46 dated 14 March 1980. The Company's Articles of Association were approved by the Minister of Justice in a decision letter No. Y.A.5/264/20 dated 26 July 1980, the letter was registered at District Court Office Jakarta No. 4404 and No. 4405 dated 27 August 1980 and published in the State Gazette No. 96 added No. 1169 dated 30 November 1984. Based on the notarial deed of Lieke L. Tukgali, SH No. 42 dated 10 May 1996, in Jakarta the Company's name had been changed from "PT. Green Pub" to PT. Setiamandiri Mitratama.*

*Based on the notarial deed of Fathiah Helmi, SH No. 66 dated 25 June 2004, in Jakarta the Company's name had been changed from PT. Setiamandiri Mitratama Tbk. to PT. Eatertainment International Tbk.*

*The Company's domicile is in Jakarta and in accordance with article 3 of the Company's articles of association, the scope of its activities is engaged in the restaurant, games, services, trading, delivery, and agency.*

## 2. Ikhtisar Kebijakan Akuntansi

Berikut ini adalah kebijakan akuntansi yang diterapkan Dalam penyusunan laporan keuangan Perusahaan, yang dengan prinsip akuntansi yang berlaku umum di Indonesia.

### a. Dasar Penyusunan laporan keuangan konsolidasian

Dasar penyusunan laporan keuangan konsolidasi, kecuali untuk laporan arus kas, adalah dasar akrual. Mata uang pelaporan yang digunakan dalam penyusunan laporan keuangan konsolidasi adalah mata uang Rupiah, yang pengukurannya disusun berdasarkan nilai historis.

Laporan arus kas konsolidasi disusun dengan menggunakan metode-langsung dengan mengelompokkan arus kas dalam aktivitas operasi, investasi dan pendanaan.

### b. Pihak-pihak yang mempunyai hubungan istimewa

Transaksi hubungan istimewa meliputi pengalihan sumber daya atau kewajiban antara pihak-pihak yang mempunyai hubungan istimewa. Seluruh transaksi yang dilakukan dengan pihak yang mempunyai hubungan istimewa, bila ada, baik yang dilakukan dengan atau tidak dengan tingkat harga, persyaratan dan kondisi normal sebagaimana dilakukan dengan pihak di luar hubungan istimewa, diungkapkan dalam laporan keuangan.

Pihak-pihak yang dianggap mempunyai hubungan istimewa adalah bila satu pihak mempunyai kemampuan untuk mengendalikan pihak lain atau mempunyai pengaruh signifikan atas pihak lain dalam mengambil keputusan keuangan dan operasional, yang meliputi :

- i. Perusahaan yang melalui satu atau lebih perantara, mengendalikan, atau dikendalikan oleh, atau berada dibawah pengendalian bersama, dengan perusahaan pelapor (termasuk holding companies, subsidiaries dan fellow subsidiaries);
- ii. Perusahaan asosiasi;
- iii. Perorangan yang memiliki, baik secara langsung maupun tidak langsung, suatu kepentingan hak suara di perusahaan pelapor yang berpengaruh secara signifikan, dan anggota keluarga dekat dari perorangan tersebut (yang dimaksudkan dengan anggota keluarga dekat adalah mereka yang dapat mempengaruhi atau dipengaruhi perorangan tersebut dalam transaksinya dengan perusahaan pelapor);

## 2. Summary of Significant Accounting Policies

*Presented below are the significant accounting policies adopted in preparing the financial statements of the Company, which are in conformity with accounting principles generally accepted in Indonesia.*

### *a. Basis of preparation of the consolidated financial statements*

*The consolidated financial statements, except for the statement of cash flows, are prepared under the accrual basis of accounting. The reporting currency used in the preparation of the consolidated financial statements is the Indonesian Rupiah, while the measurement basis used is the historical cost.*

*The consolidated statements of cash flows are prepared using the direct method by classifying cash flows on the basis of operating, investing and financing statements.*

### *b. Transaction with related parties*

*Transaction with related parties arise from resources or liabilities transfer among related parties. All transaction occurred among related parties, if any, conducted with normal or abnormal price level, qualifications, and conditions, as being conducted with unrelated parties, are disclosed in the financial statements.*

*Party being considered as related party if a party has the ability to exercise control other party or has significant influence over the other in making financial and operational decision, as defined as follows :*

- i. Enterprise that, through one or more intermediaries, control are controlled by, or are under common control, with the reporting enterprise (including holding companies, subsidiaries and fellow subsidiaries);*
- ii. Associated company*
- iii. Individuals owning, directly or indirectly, an interest in the voting power of the reporting enterprise that gives them significant influence over the enterprise, and close members of the family of any such individuals (close members of a family are defined as those members who are able to exercise influence or can be influenced by such individuals in conjunction with their transactions with the reporting enterprise);*

- iv. Karyawan kunci, yaitu orang-orang yang mempunyai wewenang dan tanggung jawab untuk merencanakan, memimpin dan mengendalikan kegiatan perusahaan pelapor yang meliputi anggota dewan komisaris, direksi dan manager serta anggota keluarga dekat orang-orang tersebut;
- v. Perusahaan dimana suatu kepentingan substansial dalam hak suara dimiliki baik secara langsung maupun tidak langsung oleh setiap orang yang diuraikan dalam 3) atau 4), atau setiap orang tersebut mempunyai pengaruh signifikan atas perusahaan tersebut. Ini mencakup perusahaan yang dimiliki oleh Komisaris, Direktur atau pemegang saham mayoritas dan perusahaan pelapor, dan perusahaan-perusahaan yang mempunyai anggota manajemen kunci yang sama dengan perusahaan pelapor.

### c. Persediaan

Persediaan dinyatakan berdasarkan biaya perolehan. Biaya perolehan untuk persediaan bahan baku dan bahan penolong ditentukan dengan metode FIFO.

### d. Prinsip-prinsip konsolidasi

Laporan keuangan konsolidasi mencakup akun-akun Perusahaan dan Anak Perusahaan dengan pemilikan lebih dari 50%, baik langsung maupun tidak langsung, kecuali Anak Perusahaan yang pengendaliannya bersifat sementara atau terdapat pembatasan jangka panjang yang mempengaruhi kemampuan Anak Perusahaan untuk memindahkan dananya ke Perusahaan.

Saldo dan transaksi termasuk keuntungan/kerugian yang belum direalisasi atas transaksi antar Perusahaan dieliminasi untuk mencerminkan posisi keuangan dan hasil usaha Perusahaan dan Anak Perusahaan sebagai satu kesatuan usaha.

Anak Perusahaan dimana Perusahaan mempunyai kepemilikan saham secara langsung yaitu : Putt-Putt South East Asia Limited (Putt-Putt SEAL) – persentase kepemilikan 100%. Putt-Putt SEAL berkedudukan di British Virgin Islands, dimana dalam laporan keuangan Anak Perusahaan menggunakan mata uang Dollar (USD).

Untuk tujuan konsolidasi, aktiva dan kewajiban Anak Perusahaan yang laporannya disajikan dalam mata uang asing dijabarkan ke dalam Rupiah dengan kurs yang berlaku pada tanggal neraca, sedangkan pendapatan, beban serta arus kas dijabarkan dengan kurs rata-rata. Selisih kurs yang terjadi disajikan sebagai bagian dari ekuitas pada akun "Selisih kurs karena penjabaran laporan keuangan".

iv. *Key personnel, that is those persons having authority and responsibility for planning, directing and controlling the activities of the reporting enterprise, including commissioners, directors and manager of the enterprise and close members of the families of such individuals;*

v. *Enterprise in which a substantial interest in the voting power is owned, directly or indirectly, by any person described in (3) or (4), or over which such a person is able to exercise significant influence. This definition includes enterprises owned by commissioners, directors or major stockholders of the reporting enterprise and enterprises that have a member of key management in common with the reporting enterprise.*

### c. Inventories

*Inventories are stated at cost. Cost of main materials and other materials is determined by the first-in first-out method.*

### d. Consolidated principles

*The consolidated financial statement include accounts of Company and its subsidiary where the Company has direct or indirect ownership interest of more than 50%, other than those excluded because control is temporary or due to long term restrictions significantly impairing the subsidiary's ability to transfer fund to the Company.*

*Intercompany balances and transactions including unrealized gains and or losses on intercompany transactions are eliminated to reflect the financial position and the results of operation of the Company and its subsidiary as a single business entity.*

*Subsidiary in which the Company has directly shares of ownership is : Putt-Putt South East Asia Limited (Putt-Putt SEAL) 100% of ownership. Putt-Putt SEAL resided in British Virgin Island, which use US Dollar (USD) as reporting currencies.*

*For consolidation purposes, assets and liabilities of the subsidiaries whose financial statements are presented in foreign currencies are translated into Rupiah using the exchange rates at balance sheet date, while revenue, expenses and cash flows are translated at the average rates of exchange for the year. The resulting translation adjustments are shown as part of equity under the account "Translation Adjustments".*

*Transaction denominated in a foreign currency are converted into Rupiah at the exchange rate prevailing at the date of the transaction. At the balance sheet date, monetary assets and liabilities in foreign currencies are translated at the exchange rates prevailing at that date.*

*Exchange gains and losses arising on transactions in foreign currency and on the translation of foreign currency monetary assets and liabilities are recognized in the income statement. The foreign exchange rates used were IDR 10.225,- and IDR. 9.054,- in balance sheets as of June 30, 2009 and 2008, respectively.*

### **i. Income tax**

*Deferred income tax is provided using the liability method, for all temporary differences arising between the tax base of assets and liabilities and their carrying values for financial reporting purpose. Currently enacted tax rules are used to determine deferred income tax. Compensable balance of fiscal losses is recognized as deferred tax assets if great is the possibility that future amounts of fiscal profit will be adequate to be compensated. Correction upon taxation obligations is recognized when tax assessment letter is received or if appealed against, when the result of the appeal is determined.*

### **j. Revenues and expenses recognition**

*Revenues were recognized at the time goods or services being rendered, meanwhile expenses were recognized according to the usefulness in the current period (accrual basis).*

### **k. Earnings per share**

*Earnings (loss) per share is computed by dividing operating income (loss) and net income (loss) by weighted average number of shares outstanding during the year.*
